## **OVERVIEW**

  insurance market in the State of Rhode Island and that it refused to negotiate in good
  faith regarding reimbursement rates for a Rhode Island hospital.
- Defended a Rhode Island hospital in an investigation by the United States Attorney's Office and the Office of Inspector General concerning alleged Stark violations.
- In a case of first impression, represented a Chinese pharmaceutical company in a
  multi-state, multi-jurisdictional regulatory and criminal prosecution arising out of
  baseball's "Mitchell Report" that involved the distribution of HGH in the United States
